**RESOLUTION AUTHORIZING AGREEMENT FOR CERTAIN
PROFESSIONAL SERVICES ADOPTED BY THE
BOROUGH OF GLASSBORO FOR THE YEAR 2011
(COMPUTER NETWORKING/MONITORING SERVICES-UNITED
COMPUTER)**

WHEREAS, there exists a need for specialized services on behalf of the Borough of Glassboro; and

WHEREAS, funds are or will be available for this purpose; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 requires that notice with respect to contracts for Professional Services awarded without competitive bids must be publicly advertised.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Glassboro, County of Gloucester, and State of New Jersey as follows:

1. United Computer is hereby hired as the Computer Networking/Monitoring Services for the Borough of Glassboro for the year 2011.
2. The term of this contract shall be from May 1, 2011 to December 31, 2011.
3. The Contract is awarded without competitive bidding as a “Professional Service” in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-11-5(1)(a), because it is for services performed by persons authorized by law to practice a recognized profession and pursuant to the Fair and Open Process.
4. A copy of this resolution as well as the Contract shall be placed on file with the Clerk of the Borough of Glassboro.
5. A notice in accordance with the Local Public Contracts Law of New Jersey shall be published in THE GLOUCESTER COUTNY TIMES or THE SENTINEL OF GLOUCESTER COUNTY.

6. The Mayor and/or Administrator and the Municipal Clerk of the Borough of Glassboro are hereby authorized to execute a Contract outlining the above on behalf of the Borough of Glassboro.


